January

Jan 1: New GAAR, AMT, Intergenerational Transfers, Employee Ownership Trust Rules begin. HR department to distribute:

- File TD1 Tax Credits Return; T1213 Request to Reduce Tax Withholdings at Source. Full time remote employees: Prov. of Residence is Employer's. Auto benefits, deductions change.
- Definition of tax preparer for EFILE: File 5 or more returns
- Remittances to Receiver General over \$10K must be electronic

Jan 2: Contribute to TFSA Annual limit \$7000; Lifetime limit \$95,000 Contribute to FHSA Annual Limit \$8000. Lifetime Limit \$40,000

Feb 27: Canada Veterans' Disability Benefit payment date

Feb 29: T4, T4A, T5 Slip filing deadline, receive enrollment notice if RRSP LLP withdrawal made in the prior year. **Assemble self-reported casual income:** tips, casual employment, no-slip interest income, receipts for discretionary deductions and credits.

Feb 29: RRSP contribution deadline

Mar 30: Canada Veterans' Disability Benefit payment date

Mar 30: Normal Tax filing due date for trusts with Dec. 31 year end, T3 slips due, 90 days after year end

Mar 30: File *Form T1-OVP* for Excess RRSP, PRPP, SPP Contributions Normal due date is 90 days after year end

Apr 2: Trust, T3, T1-OVP Return Filing Deadline

- Deceased Taxpayers: Died Jan. 1 to Oct 31 file by April 30
- New: electronic signatures accepted on T2200 and T1223

May 1: Interest is charged on tax balance due

Snowbirds: file Closer Connection Exception Statement for Aliens (*IRS Form 8840*); File extension to file US tax return (*IRS Form 4868*)

June 30: (Sunday) Form RC243 TFSA Return and RC243-Schedule A – Excess TFSA Amounts; filing due date for Section 216, 217 Returns to report net rental income from Canadian-source rental income.

July 2: File Form RC243, Section 216,217, deceased Returns

Capital Gains Review: Tax-loss harvesting to offset capital gains income.

Donations Plan: Review transfers of securities to charity to avoid capital gains tax

Retirees: Review Severance, RRSP meltdown strategies, RRIF income levels, OAS clawback, take CPP early or later?

Nov 1: File T1 return to qualify for automatic Canada Workers Benefits advances

- NR6 Non-residents who collect rental income or timber royalties in Canada should file this form on or before the first day of each tax year, or when the first rental payment is due.
- Last day to correct errors and omissions to 2014 T1
 Canada Child Benefits: Correct errors & omissions.
- Retroactive payments for the CCB can be made for 10 years.

* Must be Canadian resident and 18 or older

** Complete attestation form RC669-21e. Retroactive claims can be made on a case-by-case basis after all deadlines have passed.
